

**MINUTES OF THE MEETING
OF
VERMILION PARISH SCHOOL BOARD**

July 24, 2008

The School Board met this day in regular session at 216 South Jefferson Street, Abbeville, Louisiana, at 6:00 p.m., with the following members present: Mr. Ricky Broussard, Mr. Dexter Callahan, Mr. Charles Campbell, Mrs. Angela Faulk, Mr. Anthony Fontana, Mr. Ricky LeBouef, Mr. Chris Mayard, and Mr. Bill Searle.

Superintendent's Office:

On motion of Mr. Fontana, seconded by Mr. Fontana and carried, the Board adopted the following resolution granting the authority to the Superintendent to sign documents related to the Community Development Block Grant (CDBG) program:

RESOLUTION

A RESOLUTION GRANTING THE AUTHORITY TO THE SCHOOL BOARD SUPERINTENDENT TO SIGN AND SUBMIT ALL NECESSARY DOCUMENTS IN CONNECTION WITH THE COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY PROGRAM THROUGH THE SCHOOLS RECOVERY LONG TERM COMMUNITY RECOVERY PROGRAM

WHEREAS, The Vermilion Parish School Board is scheduled to receive Disaster Recovery Funds under the Community Development Block Grant Schools Recovery Long Term Community Recovery Program; and

WHEREAS, this federal grant program which is administered by the Louisiana Division of Administration, Office of Community Development involves filing applications along with a significant amount of documentation and reporting relative to the implementation of the projects; and

NOW, THEREFORE BE IT RESOLVED by the Vermilion Parish School Board that the Superintendent is hereby authorized to sign and submit the application, the Cooperative Endeavor Agreement and any amendments or extensions thereof, and the environmental review record, all of the necessary reports, studies, plans, certifications, assurances, contracts, change orders and any other documents required in connection with the Community Development Block Grant Schools Recovery Long Term Community Recovery Program.

THEREUPON, The above resolution was duly adopted.
